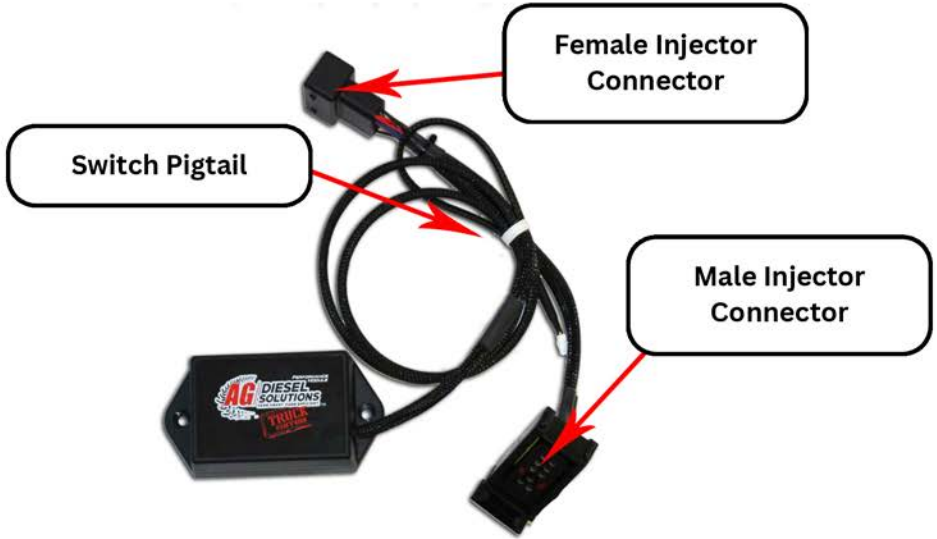

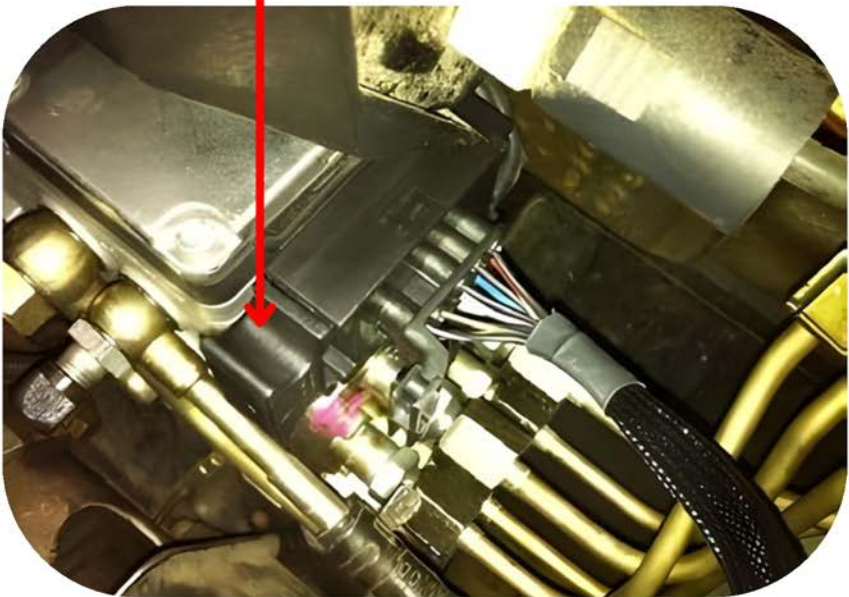

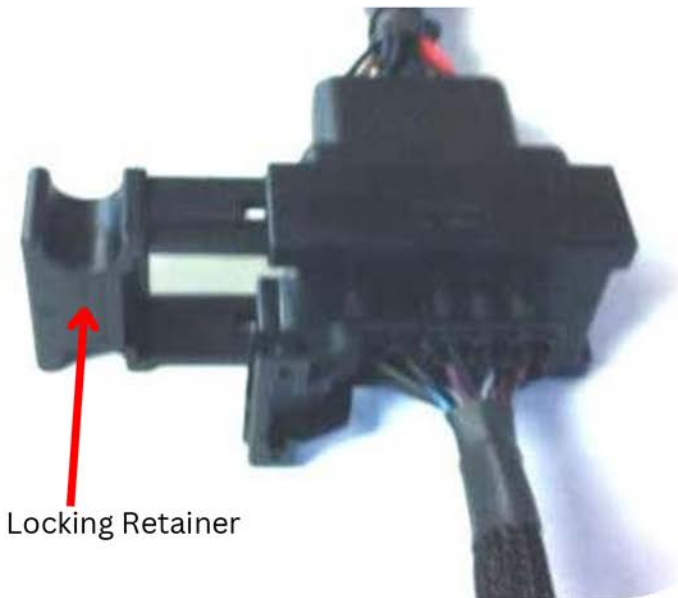


**Step 1)** From the tractor cab looking forward, locate the pump on the left side of the engine. You will see the injector lines coming out of it.

Locking Retainer

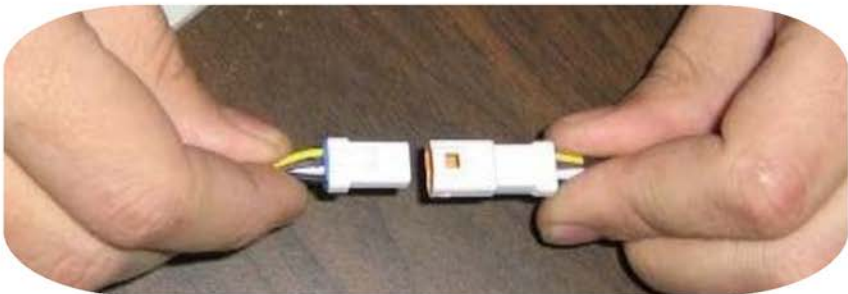


**Step 2)** Slide out locking retainer and remove wiring harness.



**Step 3)** Plug female connector from module directly into Injection Pump. Plug the male connector from module into the stock harness that was removed from Injection Pump.

**\*Note:** Make sure the locking retainer slides in and is securely fastened.



**Step 4)** Mount the module box in a safe location using the zip ties to secure the wires and modules away from any extreme heat and moving parts.

**Step 5)** Once you have installed the module, connect the switch to the switch pigtail. Once connected you can zip tie it to the module and leave it in place.
